- Copy of VAT registration and evidence of past VAT remittances for completed projects
- Current Company's audited statement of Accounts for the last three years(2011-2013), duly stamped by a Registered Auditor
- Evidence of compliance with Industrial Training Fund (ITF) Amendment Act, 2011 2004 by inclusion of compliance Certificate from ITF
- Evidence of compliance with Pension Reform Act, 2004 by inclusion of Clearance Certificate from National Pension Commission (PENCOM)
